

Contractual Agreement



This signed document is an agreement between **Deb's Pet Buddies, LLC** and _____ (Client) for pet care services beginning on _____, until revoked in writing.

1. I authorize **Deb's Pet Buddies, LLC** to perform pet care services as outlined in the Client Information Form, Pet Information Form, Policies and Procedures Form and Veterinary Authorization Form, which shall become part of this contract.
2. I authorize **Deb's Pet Buddies, LLC** to obtain any emergency veterinary care that may be necessary during the time spent with my pet. I accept responsibility for any charges related to this emergency care. I also authorize **Deb's Pet Buddies, LLC** to utilize an alternative veterinarian in the event my primary veterinarian is unavailable. Every effort will be made to contact the owner prior to obtaining emergency care.
3. **Deb's Pet Buddies, LLC** accepts no responsibility for security of the premises or loss if other individuals have access to the home before, during, or immediately after the term of this agreement.
4. I agree to reimburse **Deb's Pet Buddies, LLC** for any additional fees for providing emergency care, as well as any expenses incurred for unexpected visits, transportation, housing, food, or supplies.
5. **Deb's Pet Buddies, LLC** agrees to provide the services stated in this agreement in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives and relinquishes any and all claims against **Deb's Pet Buddies, LLC**, its employees or assigns, except those arising from proven negligence of the pet sitter.
6. **Deb's Pet Buddies, LLC** will not be liable for the injury, disappearance, death, or fines of any pet with unsupervised access to the outdoors.
7. **Deb's Pet Buddies, LLC** reserves the right to terminate this contract at any time, at its sole discretion; likewise, client may terminate this contract at any time as per the Policies and Procedures.
8. It is expressly understood that **Deb's Pet Buddies, LLC** shall not be held responsible for any damage to client's property or that of others, caused by client's pet during the period in which they are in its care. Client has advised **Deb's Pet Buddies, LLC** of all situations, which will relieve it of liability for damage.
